(a) Martha Salas, Finance Director addressed the Council regarding the Financial reports for the month of February, 2022. The Finance Officer explained how she had worked diligently to reduce the amount of CD's that were being invested from approximately 40 down to 5 which will make it easier for investment purposes and that there would be no more non-interest bearing accounts in the future. Frank Madrid came before the Council and explained that the agreement needs to be re-negotiated as the original agreement was signed before internet and fiber optics came into being and that it needs to be updated to include those items. The agreement will be presented to WNMT Co. at a cost of \$1,500.00 per year with the addition of internet and fiber optics and the specification that the property belongs to the City of Lordsburg to do with it as they see fit. c). Utilization of the American Relief Act Plan to install fiber optics from City Hall to City Buildings was discussed. IT Manager Vern Richardson explained that what we have now is not dependable and that fiber optics will make for a more stable network. Mayor Pro-Tem Alvarez made the motion to use these funds to improve our network, 2<sup>nd</sup> by Councilor Saucedo. City Clerk polled the Council. Motion was carried.

Under the MOU, the County has agreed to assist the City by obtaining and administering a NMFA Colonias Infrastructure Board Loan which includes design and improvements.
